### RULES AND REGULATIONS

For the enjoyment of all golfers and guests, and to maximize the safety and recreational experience at Bigwood, please respect the Rules and Regulations.

1. Players check in at the golf shop 15 minutes prior to their tee time.
2. Players play in foursomes with only two players per cart and two carts per group. Adult spectators are at the discretion of the golf shop staff. No child spectators under age 6. Players need a driver's license to rent a power cart.
3. Each player must have a set of clubs.
4. No pets allowed.
5. Play ready golf. Bigwood strives to keep a pace of play for everyone's enjoyment of the game. 9 holes = 2 hours 10 minutes.
6. Call one week in advance for tee times. Please let the golf shop know if playing 9 or 18 holes. The golf shop will make a turn time for you if playing 18 holes.
7. Junior golfers are high school age or younger and must know rules and etiquette of the game.
8. Players are responsible for any/all damage incurred to private/personal property while on the course or practice grounds.
9. Proper golf attire and shoes are required. Male: Shirts with collars, no t-shirts. Female: shirts with sleeves or collars, no tank tops. Denim in good condition is permissible.
10. Beverages and food must be purchased at Bigwood.
11. Bigwood is a soft-spike facility.
12. Appropriate conduct and proper golf etiquette is expected at all times.
13. Failure to follow these regulations will result in loss of playing privileges.
